## **Use of Key Cards**

Please report lost key cards immediately so they can be deactivated. We can also check the camera system to ascertain the identity of an individual using a keycard.

Per the HOA Covenanted and Restrictions (available at [www.pablobay.com](http://www.pablobay.com)) the owner is responsible for any damage a visitor causes.

Each key card is magnetic encoded to your family only and may be transferred to another new owner by sending email notice to [poolmonitor@pablobay.com](mailto:poolmonitor@pablobay.com). The new family must have the same information form complete.

Lost key cards will cost \$26.50 for replacement. (the old card will be disabled)  
Additional key cards (beyond 2 per family) will cost \$53 since they require a new database entry program. See [www.pablobay.com](http://www.pablobay.com) for more information.

## **Pool Rules**

Non Payment of HOA fees, misuse of the key card system, repeated violations of Pablo Bay Covenants may be reason for disabled access. Please contact the Gealean at 625-0111 or send an email to [poolmonitor@pablobay.com](mailto:poolmonitor@pablobay.com) should you have any access problems.

- 1) Anyone who does not know how to swim and is smaller than 48" must wear some form of a floatation device.
- 2) Children under the age of 12 must be supervised by an adult over the age of 18.
- 3) Anyone found using a Key Card improperly will have that Key Card disabled.
- 3) The pool hours are from dawn till dusk 7 days a week. There is NO life guard on duty.
- 4) No diving, running, horse play or other activity that may be considered dangerous will be allowed.
- 5) No food outside of the designated eating areas.
- 6) No foul language
- 7) No rafts, floating lounge chairs, or other pool equipment will be allowed. The Pool Monitor will determine which items may be used in the pool.
- 8) Please shower before entering the pool.
- 9) Children who are not potty trained must use swim diapers.
- 10) No dogs or bicycles/skate boards on the pool deck/pavers.
- 11) No alcohol or glass containers allowed on the pool deck.
- 12) Any child under the age of 7 must be attended in the bathrooms.
- 13) Proper dress attire is required for a family environment. No Brazilian cut bikinis or thongs.
